AND WHEREAS, the Upacharya has decided to place Dr. Shubhra Jyoti Das, Assistant Professor, Department of Philosophy & Comparative Religion, Visva-Bharati under suspension with immediate effect pending the disposal of the Disciplinary Proceedings or until further order whichever is earlier so that he will have no access to the records relating to the Disciplinary Proceedings.


NOW THEREFORE, the undersigned is directed to communicate that Dr. Shubhra Jyoti Das, Assistant Professor, Department of Philosophy & Comparative Religion, Visva-Bharati has been placed under suspension with immediate effect.

It is further conveyed that during the period that this order shall remain in force the headquarter of Dr. Shubhra Jyoti Das, Assistant Professor, Department of Philosophy & Comparative Religion, Visva-Bharati will be Santiniketan and that Dr. Shubhra Jyoti Das, Assistant Professor, Department of Philosophy & Comparative Religion, Visva-Bharati shall not leave the headquarter without obtaining the prior written permission of the undersigned.

During the suspension period, Dr. Shubhra Jyoti Das, Assistant Professor, Department of Philosophy & Comparative Religion, Visva-Bharati will be allowed Subsistence Allowance at an amount equivalent to the leave salary which he would have drawn if he had been on leave on half average pay / half pay and in addition to Dearness Allowance as per FR-53 or any other applicable Rule/Order of the Govt. of India or Visva-Bharati.
