NOTES on Bhasa-Bhavana Financial irregularities

In Bhasha-Bhavana every month a small amount (Rs.2000/-) was drawn in the name of a fictitious person which was distributed among two temporary staff Subir Goswami and Panchanan khan who worked overtime. But for the same "crime", VB authority imposed different kinds of punishment on the employees, which was noted and dismissed by CHC. All the temporary staffs associated with Bhasha Bhavana, namely, Subir Goswami, Panchanan Khan, Shrabanti Ganguly were removed from service. Among them Shrabanti did not have any contact with Bhasha-Bhavana office (She had duty in Bhasha Bhavana library situated at different floor of the same building) where the incident took place. Two section officers namely Soumen Saha and Ganesh Ghosh were compulsorily retired. Among three Principals, Prof. Abhijit Sen were free on HC court order. Two Principals Professors Kailash Patnaik and Narottom Senapati were scot-free after paying minor penalty of small amount of money. Amar Karmakar and Ranjan Rashmi Senapati were two employees of Bhasha-Bhavana were joined after suspension with minor penalty.
