
Your Excellency,

We welcome you to Visva-Bharati and Santiniketan. This is the place where Rabindranath Tagore, the great son of India, started an unique experiment in education which in both content and form would be completely different from that provided by the colonial masters. Another uniqueness of the experiment was adopting and involving the villagers, mostly marginal people, living in the surrounding villages in a development programme that included all aspects of rural life from agriculture to health.

Sadly, the situation at Visva-Bharati has reached an alarming state in the last few years. It seems that the sole purpose of Prof. Bidyut Chakrabarty, the incumbent Vice-Chancellor, is to persecute and insult the stakeholders, particularly the faculty members. His draconian and illegal actions and abuses have done irreparable damages to this great institution and severely affected a large number of faculty members. In the NIRF ranking Visva-Bharati's position of the universities has gone down from 31 to 98 during his tenure and NAAC has given a very poor grade.

The affected faculty members, staff and students had to knock at the door of the High Court to seek justice. We draw your attention to a few of these.

- 1. Shri Bijju Sarkar, a student from a poor dalit family was thrown out of the hostel within 24 hours for circulating a video of Prof. Chakrabarty's speech on the occasion of Republic Day in 2019 without following any procedure!
- 2. The Hon'ble High Court has imposed a fine of Rs. 1,00,000 for malicious prosecution of Prof. Debotosh Sinha of the Department of Social Work. "Such a vindictive attitude of the University cannot be approved by this Court and should be deprecated by awarding appropriate costs.
  Accordingly, the University is directed to pay a cost of Rs.1,00,000/- (one lakh) to the petitioner ..." (W.P.A. 27669 of 2022, Sri Debotosh SinhaVs. Visua-Bharati & ors.)



- 3. Dr. Shaona Barik, a lady faculty member belonging to the SC, was not granted permission to avail a prestigious fellowship in UK. This has not only affected her career but also damaged the institution academically. The Hon'ble High Court has struck down this as illegal.
- 4. Prof. Chakrabarty viciously withdrew the No Objection Certificate for participating in an international research project at CERN, Geneva. Not only did this affect the University academically, but also lost a large sum in revenue. "The letter of the Vice-Chancellor discloses a biased mindset which is unbecoming of the head of the University. The letter reflects a small-minded approach since it relates to a prestigious international project. The letter has resulted in the unfortunate decision of the DST reviewing its earlier sanction to the petitioner for participating in the project." (Manas Maity .vs. Visva-Bharati, WPA 11522 of 2021)
- 5. Dr. K.V. Rajesh was not granted permission to avail a fellowship. This again was struck down as illegal by the Hon'ble Court.
- 6. Dr. Rakesh Kundu was not given permission to avail a fellowship to visit Germany.
- 7. Prof. Chakrabarty manipulated the reports of external experts to deny promotions to several faculty members. The Hon'ble Court has struck down as illegal the denial of promotions to two faculty members.
- The Hon'ble Court has set aside Prof. Tathagata Choudhury's punishment of deduction of two increments.
- 9. Show cause notices, suspensions, sham inquiries, punishments, defiance of court orders are the order of the day and demoralized the entire community. At least 13 faculty members have been suspended for a total period of more than 162 months. At least 14 faculty members have been removed from their positions of Heads of Departments, Principals of Bhavanas, etc.
- 10. The Executive Council, at the behest of Prof. Chakrabarty, proceeded to terminate the service of Prof. Sudipta Bhattacharyya without even holding an inquiry!

There are many such instances and the administration's major preoccupation is defending the illegal acts of Prof. Chakrabarty in the Courts. The University is spending huge sums for the cases. There is no effort for academic and infrastructural development.

Time and again we have brought to the notice of the Hon'ble Visitor, the Hon'ble Chancellor and the Hon'ble Minister of Education, the illegal, draconian actions of Prof. Chakrabarty along with supporting documents. Unfortunately, we have not seen any corrective steps so far. We earnestly request you to take urgent remedial actions and save this Institute of National Importance and its stakeholders.

A video was widely circulated at the media that VC himself pelted stones at the students on 12.01.2023.

VC has been regularly escorted from his residence to office by his wife, daughter and son and state police forces plus 150 University security guards. It is also seen in a video from the cordon escorted him from the residence to office, VC 'ordered' Officer-in-charge (OC) of Santiniketan PS to snatch cameras from a journalist. When the OC refused to comply VC's 'order', VC was seen to tell the OC to get lost as VC had no need for him. In 2020 he snatched mobile from a journalist where VC himself involved in physical tussles with the journalist. A case is still pending in Calcutta High Court (CRR No. 1338 of 2020) following the FIR from the journalist at Santiniketan PS (Case No. 112 of 2020 dated 01.08.2020). All these are indications of VC's criminal state of mind.


